#### **Recap the facts**

#### **Project status**

The Project has been formally called in for assessment by the Deputy Premier and Planning Minister. Cubico welcomes the opportunity to engage closely with the Deputy Premier to demonstrate how the Project is designed to deliver sustainable energy for Queensland while minimising impacts and supporting tangible co-benefits for the local community and region.

The Department of Climate Change, Energy, the Environment and Water has issued final guidelines for the preparation of a Public Environment Report (PER). The Project team is now progressing the PER to provide transparent and robust verification of how environmental impacts will be managed.

Ongoing support is being provided for local initiatives, alongside planning for upcoming community events to continue meaningful engagement.



15km from Wandoan and Guluguba and approximately 60km north of Miles in the Western Downs Regional Council area



Up to 183 (subject to approvals) with turbine tip height up to 260 metres



Up to 1.317 GW generating capacity



Via the existing Columboola to Wandoan South 275kV transmission line located approximately 22km south of the Project



Up to 800 MWh of storage and grid stabilising services given a co-located Battery Energy Storage System (BESS)



Up to 35 years



Since 2023, local businesses and community groups have benefited from pre-development funding for the Middle Creek project, with support to continue during construction and operation.

Up to 500 during construction, followed by several long-term local positions during 35 years of operation

# **Project Update**

The Middle Creek Energy Hub continues to progress through key environmental and planning approvals, including detailed assessments of ecology, water, and social factors such as workforce accommodation.

These assessments help ensure the Project is developed responsibly, with a focus on minimising environmental impacts and addressing community needs. As we move forward, we remain committed to balancing the Project's benefits with the priorities of the local community.

#### Development Application and Proposed Ministerial Call-In Response (State Permitting Process)

The Project submitted its Development Application (DA) in December 2024, which was prepared in line with the State Code 23 guidelines for wind farm developments. The application includes detailed assessments of environmental, technical and social factors. These assessments cover key aspects such as ecology, noise, traffic and visual impacts to ensure the Project aligns with state planning and development requirements.

Recently, the Project's Development Application (DA) has been `called-in' by the Deputy Premier.

### What does this the call-in decision mean for the Project?

The Project being called-in means that the Deputy Premier has exercised his powers under section 103 of the Planning Act 2016 to call in, assess and hold final decision on whether to approve the Development Application made for the Middle Creek Energy Hub.



We are committed to ongoing engagement with the community and will continue to provide updates and seek feedback, particularly on initiatives such as the community benefits program.

The Project will now work closely with the Deputy Premier and the Department of State Development, Infrastructure and Planning in their assessment of the Project's DA.

The Project team has already completed a significant body of work to demonstrate that it complies with the updated version of the State Code 23, v 3.2 and is confident this assessment process by the Deputy Premier and the Department of State Development, Infrastructure and Planning will yield a positive outcome for the Project, the community and the state of Queensland.

As part of this process, the Project team will continue to work closely with the Western Downs Regional Council (WDRC) and local residents to address local concerns and ensure the project aligns with the WDRC's strategic objectives.



#### **EPBC Referral (Federal Permitting Process)**

In September 2024, the Middle Creek Energy Hub was referred to the Department of Climate Change, Energy, the Environment and Water (DCCEEW) under the Environment Protection and Biodiversity Conservation Act 1999 (EPBC Act). The referral process assesses whether the Project is likely to have a significant impact on matters of national environmental significance and determines the level of assessment required.

The proposal was made publicly available for a 10-business-day consultation period in January 2025, allowing community members to review and provide feedback directly to the Department. Following its review, DCCEEW determined that the Project is a `controlled action' requiring assessment through a Public Environment Report (PER). A copy of the decision notice is available on the <u>EPBC Public Portal</u> for those interested in reviewing the determination in full.

Submission of a Public Environment Report is an additional formal process to confirm and build upon the extensive avoidance, mitigation and engagement measures already embedded in the Project's design. This assessment will provide another opportunity to validate these efforts and address remaining key environmental matters through further studies and transparent reporting. Final guidelines for preparing the PER were issued by DCCEEW on 28 May 2025, following a draft guideline consultation period in April 2025. The Project is now progressing with the development of its PER in accordance with the finalised guidelines issued by DCCEEW.

#### **Proposed Turbine Layout**

The turbine layout map below shows the proposed locations of wind turbines for the Middle Creek Energy Hub. This layout has been designed with careful consideration of environmental, visual and technical factors to minimise impacts and optimise energy generation.

Please note that this is a proposed layout and may be subject to further refinement as the Project progresses through the environmental and planning approvals process.

The layout was developed in close consultation with landholders. Access roads have been designed to follow existing tracks or fence lines wherever possible, and where this is not feasible, new access tracks will be aligned in consultation with landholders. This approach aims to minimise disruption to current land uses, including agricultural activities, and to maintain flexibility for future land use. The design process, which took six to twelve months, included in-person ground truthing to confirm the proposed infrastructure locations.



## Engaging with the local community

The Middle Creek Energy Hub team remains committed to open and transparent communication, prioritising discussions with residents closest to the site while also expanding our outreach to the wider community as the Project progresses.
